Recent publicity involving the Branson School has suggested the possibility of that longtime Ross institution leaving the town

and relocating at the Golden Gate Seminary premises in the Strawberry area of Mill Valley. In recent months representatives of the Town have met with the Head of School and members of the school's board of trustees to discuss the school's relationship with the town. Over several years there have been discussions of the school's impact on traffic and parking and the school's efforts to alleviate that problem by arranging off-campus parking and the use of shuttle buses to transport students to the campus. Those efforts continue. The school has suggested that the limi-

Town Council Goes High-Tech



In the Town's ongoing effort to upgrade its technology, the Council began using iPads at the April meeting. This technology enables the Council to view and annotate Council meeting agenda documents on their iPad screen, and reduces the amount of paper generated for each Council meeting. The Council will

still review plans for Planning projects in hard copy, as they are best viewed on large-sized paper.

IPads and tablets are very mainstream now, particularly for use at meetings, and are already being widely used at many cities and agencies. Some of the Council already owned personal iPads which made the transition for some very easy. ■

Town Earns "StormReady" Designation



The Town recently completed a set of criteria necessary to earn the StormReady distinction. "StormReady encourages jurisdictions to take a fresh approach to improving local hazardous weather and flood operations and public awareness," said Logan Johnson, of the National Weather Service (NWS). "The Town has taken an

excellent coordinated approach to severe weather and flood concerns, and shown great dedication to achieve StormReady recognition that directly benefits their citizens. This program rewards their hard work and sincere partnership with the National Weather Service."

The nationwide community preparedness program uses a grassroots approach to help communities develop plans to handle local severe weather and flooding threats. The program is voluntary and provides

tation of the student body to 320 students (imposed by initiative and vote of the residents in 1978) presents economic problems for the school's continuing viability. For those interested a recent letter to the school's alumni giving more detail about the issues under consideration has been posted on the school's website. It may be some time before any decisions are reached on any of these issues. The council will be closely following developments and will continue to keep our residents advised.

On another subject, there have been several recent instances of violation of tree protection rules, construction traffic management and resale inspection requirements; a reminder about these matters seems in order.



Ross' tree canopy is a treasure of the Town, so there are regulations in place governing tree protection. However there have been several recent instances of people removing or trimming trees without obtaining proper Town permits. While most tree companies working here know that there are required permits, there are some, especially from out of town, who may not know. If you are having tree work done, please review the Tree Alteration/Removal Fact Sheet information on the website or contact Senior Planner Elise Semonian at 415-453-1453, ext. 121, esemonian@townofross.org for more information.

There also have been issues recently about traffic control at home remodel sites. For significant projects, the Town requires that the property owner provide a construction traffic management plan for vehicles at the construction site, setting forth hours of operation, minimizing disruption to neighbors and insuring access for emergency vehicles. Residents with a significant project should make sure their general contractor or project manager adheres to the approved plan.

Finally, residents who are planning to list their homes for sale should remember that they are required to arrange a Town resale inspection when the home is listed. If the home does not sell within six months, a re-inspection is required. To arrange an inspection, call the Building Department at 415-453-1453, ext.106.

Attending to these items in advance will help to insure a smooth project.

communities with clear-cut advice from a partnership between the local NWS fore-cast office and state and local emergency managers. StormReady started in 1999 with seven communities in Tulsa, OK. There are now more than 960 StormReady communities in 48 states.

Police Chief Erik Masterson said "The StormReady program enhances flood warning preparedness within town. A lot of work goes into preparedness as Storm-Ready and we look forward to further cooperative efforts with the NWS to raise local weather and flood preparedness programs in Town." To be recognized as StormReady, a community must:



- Establish a 24-hour warning point and emergency operations center
- Have multiple ways to receive severe weather warnings and forecasts, and to alert the public
- Create a system that monitors weather conditions locally
- Promotes public readiness through community outreach and education
- Develops a formal hazardous weather plan, which includes severe weather spotters and holding emergency exercises.

"The key element of our mission is to help reduce loss of life and property from severe weather, and StormReady helps create better prepared communities," said Johnson. National Oceanographic and Atmospheric Administration (NOAA's) National Weather Service is the primary source of weather data, forecasts and warning in the US and its territories. The NWS operates the most advanced weather, flood warning, and forecast system in the world, helping to protect lives and property and enhance the national economy.

MMWD Drought Update



April 3, 2014 Update

Reservoir levels have increased to about 80% of capacity with the recent storm dropping 5.03 inches of rain. Our annual total rainfall to date is now 31.94 inches compared to the average of 47.05 for this date.

Please continue to conserve to make our supplies last. The 25% voluntary water use reduction request is still in place. Thanks to your conservation efforts water usage is **down 22**% compared with this same week last year. Keep conserving to reach a goal of 25%.



Ross Heritage Roses in Bloom



Two, highly visible species of heritage roses growing in Ross are just coming into annual bloom. Both have historical significance to Ross residents.

Before the Lagunitas Bridge was replaced, an enormous climbing rose identified as Fortune's Double Yellow and also known as Gold of Ophir, spread up into the adjoining oak tree at the northeast side along the Creek. Its bronzed yellow blooms, with a tinge of copper marked the arrival of spring. The rose bush undoubtedly was a hardy survivor from the Shotwell Family gardens of whose estate the Town purchased in 1927, and became the site of Town Hall.

When the old bridge was replaced the massive rose bush had to be torn out but fortunately, Robert Maccario of the Public Works Department, took a number of cuttings that he grew and has replanted along the creek bed. They will be blooming soon and within a couple of years will cover the entire fence.

Two more heritage rose bushes are in bloom about midway on the west side of Shady Lane, between Lagunitas Road and Ames Avenue. They are on either side of the stone pillars that marked the estate entrance of James and Sarah Coffin, who built their family home in 1890. The roses now have grown high into the nearby trees and their impressive white blossoms are beginning to cascade down. They are known as *Fortuniana*, a vigorous climber that was introduced to the United States from China in 1850.
