Flood Control Discussion

arin County Supervisor Katie Rice, Capital Planning & Project Manager Jack Curley, and FEMA representative Kathy Shaefer, along with Ross Valley Fire Chief Roger Meagor attended last night's Council meeting to discuss flood related issues such as the fish ladder, the new FEMA maps, and to update the Council on the progress of the Flood Zone 9 Advisory Board.

The Ross Valley Flood Protection and Watershed Program released their annual report which provides information on what detention basins are, highlights their milestone accomplishments from 2006-2011, 2012 accomplishments and 2013 goals.

Some of their 2013 goals include:

- Identify funding strategy with US Army Corps of Engineers for completing the "Unit 4" federal flood control project to increase creek capacity in Kentfield and Ross.
- · Continue annual creek maintenance program efforts with town/city staff to remove debris and flow-inhibiting vegetation before the rainy season.
- Complete the pre-design engineering studies for the Phoenix Lake flood detention pro-
- Complete formal agreements with the first four detention basin site owners and begin the design and environmental public review process.

The Federal Emergency Management Agency (FEMA, Department of Homeland Security) has

revised the Town Flood Insurance Rate Maps and Flood Insurance Study report. The draft flood maps include revisions and modifications to the Special Flood Hazard Area boundaries and now include Base Flood Elevations, FEMA has also added a regulatory floodway area on the Town flood maps. The formal appeal and protest period for the maps began on February 27, 2013, and ends on May 28, 2013. Council Considers Downtown Signage

t the request of the downtown merchants, the Council considered directional signage to direct drivers to business in the downtown. The downtown signage issue has been discussed on and off over the years and to date, no such signage has been permitted. The Town has a tradition of keeping signage to a minimum when it comes to drawing attention to Ross, while the community. predominantly a residential community, does have a modest

downtown with businesses of value to the community. Integral to the success of many businesses especially small businesses, is people knowing where they are. And a method of assisting those who might want to visit businesses is signage. Nearly all communities with a "business district" have some signage guiding drivers, bicyclists, and pedestrians. In many cases, the signage is directional (Continued on Page 2)



The Mayor's Report

he spring has not yet begun but the clocks moved have for-The sun has been out, the daffodils are in bloom on Lagunitas Avenue, and cherry blossoms can be seen on Shady Lane, and as we trim the hedges, cut back the overgrown vegetation, and mow the lawn, we feel lucky again to live in the beautiful environment that is Ross. We should, though, not forget that so close up to Mount Tamalpais we do experience heavy downpours every year and that, although hopefully the rains are behind us for this season, sometimes it can feel like we live in a rainforest.

As a result, last night we had a lively discussion of flood control issues. We welcomed, among others, to assist us in developing future policy for flood mitigation, Katie Rice, our County Supervisor, Jack Curley, the County's hydrologist, and Kathy Schaefer from FEMA, as well as

our own Town hydrologist, Matt Smeltzer, and the fire chief for the Ross Valley Fire Department, Roger Meagor. Their attendance on this critical issue was very much appreciated. As we enjoy warmer weather again in the coming months we must not allow dealing with flooding or other disasters to slip from being a key priority for the Town for today and for years to come. We have to keep asking ourselves what the Town can do on its own and in conjunction with the other surrounding municipalities, the County, the state and the federal government to ameliorate this issue. We have set an important example for others, by rebuilding the Lagunitas Bridge and by creating and implementing the Stormwater Ordinance, but there remains much more to do.

On a separate note, Town residents should be aware a review of Ross Rec is currently being considered and I expect this will

appear on the agenda for one or more Council meetings in the coming months. Recently the Town attorney provided a memo advising that Ross Rec is an entity of the Town of Ross and is no different from any other Town Council Committee. The Council has appointed two Council members to serve as an ad hoc committee to work with the Ross Rec Committee to address the compliance matters contained in the Town Attorney memorandum. No decisions have yet been made and information gathering is currently underway. There will be plenty of opportunity for residents and others affected to weigh in as decisions get made and issues are addressed.

showing a category of business versus the name of specific businesses. One of the challenges with signage, is they have a consistent design, are made of quality materials that last and are sized appropriately to balance

the need for drivers to adequately read the sign, and at the same time be suitable for the community in which they may be placed.

The Council asked staff to pro-

vide sign wording for the proposed number of signs (6). Staff will bring back to the Council for consideration at the April 11th meeting.

Construction Ordinance Revisited

he Police Department enforces the Town ordinance prohibiting construction beyond permitted times and on weekends. There have been some questions about the Town ordinance, so we would like to clarify some of the issues.

Construction is permitted Monday through Friday 8:00 am to 5:00 pm only. It is not permitted Saturdays, Sunday or holidays, with these exceptions:

 Work done solely in the interior of a building or structure, the performance of which does not create any noise which is audible from the exterior of the building or structure; (Workers would be permitted to be on site and working on the interior as long as no noise was made.)

- Work actually physically performed solely by the owner of the property, on Saturday between the hours of ten a.m. and four p.m. and not at any time on Sundays or other holidays. (The owner may work on their own property at times.)
- Upon issuance of a building permit authorizing an exception.

NOTE: What is prohibited by the ordinance is the actual construction work. The arrival of workers on site and clean up and departure are not actual construction. No actual work is permitted beyond permitted times.

Please report any prohibited construction to the Police Department. We will respond and require any prohibited construction to cease at once. We hope this will help clear up any misconceptions and provide residents with information to eliminate unnecessary noise.

Leaf Blower Use



e have received complaints of leaf blower noise on the weekends. Here is a reminder of the facts for leaf blower use:

- Electric leaf blowers are permitted Monday through Friday, between 8:00 a.m. and 5:00 p.m.
- Only property owners may use leaf blowers on Saturdays between 9:30 a.m. and 4:00 pm.

- No leaf blowers are allowed on Sundays and holidays.
- Gasoline powered leaf blowers are permitted only if the Public Works Department issues a special permit.
- Gardeners may use power mowers on Saturday between 9:30 a.m. and 4:00 p.m., but may not use leaf blowers of any kind on the weekend.

If you have a complaint of a gasoline powered leaf blower,

please report it to the Police Department at (415) 453-1453 option 2.

New California Recycling Requirement for Businesses and Multifamily Dwellings (AB 341)

new state law, California Assembly Bill (AB) 341, requires all businesses that generate four (4) or more cubic yards of waste per week to recycle. Businesses include, but are not limited to, non-profits, strip malls, government offices, and schools. The law also applies to multifamily dwellings of five (5) units or more, regardless of the amount of waste generated.

Businesses and multifamily dwellings are required to separate recyclable materials from their solid waste stream and either self-haul, subscribe to a hauler (which in Ross is Marin Sanitary Service), and/or allow the pickup of recyclables.
