**DESCRIPTION**: Review of plans for remodel to an existing residence and detached garage that would require Town Council approval of a Demolition Permit, Design Review, and a Nonconformity Permit. Elements of the project include an interior and exterior remodel, changes to wall coverings, windows, exterior doors, and materials, reconstruction and configuration of the garage, construction of a breezeway to connect the garage to the main residence, and alteration to exterior decks. A Demolition Permit and Design Review is required to allow for projects resulting in the removal or alteration of more than twenty-five percent of the exterior walls or wall coverings of a residence. A Nonconformity Permit is required to allow for the structural alteration to a nonconforming residence relative to floor area and setbacks.

#### b. Sitaram LLC - 9 Quail Ridge Road

**Owner: Sitaram LLC** 

**DESCRIPTION**: Review of plans for remodel and 165 square foot floor area addition of an existing residence that would require Town Council approval of a Demolition Permit and Design Review. Elements of the project include changes to existing windows, exterior doors, and materials/colors, removal of projecting eaves, the removal of the porch roof at the front entry, changes to skylights, and the installation of new solar panels. A Demolition Permit and Design Review is required to allow for projects resulting in the

removal or alteration of more than twenty-five percent of the exterior walls or wall coverings of a residence.
