DESCRIPTION: Design Review for the remodel of a single family residence that would entail an entry way remodel, second floor remodel, garage/carport remodel, and a back patio remodel. Other project features include new hardscape improvements and the demolition of two existing sheds.

b. Glasser Residence (Application No. 2016-026) – 440 Upper Toyon Drive

Applicant: Polsky Perlstein Architects

DESCRIPTION: Design Review for the new construction of a single family residence and detached pool house on a vacant lot. The project is designed with 8,300 square feet of floor area, which includes a 448 square foot pool house, a 340 square foot gym, and a 1,060 square foot garage. Other project features include new landscaping and hardscape features such as a swimming pool and terraces.

c. Glasser Residence (Application No. 2016-027) – 404 Upper Toyon Drive

DESCRIPTION: Design Review for the new construction of a single family residence and detached pool house on a vacant lot. The project is designed with 6,399 square feet of floor area, which includes a 693 square foot pool house and an 853 square foot garage. Other project features include new landscaping and hardscape features such as a swimming pool and patios.

DESCRIPTION: Design Review of the temporary placement of a 24 wide by 40 foot long portable building to be used as Town offices for 3-5 years. The maximum height of the portable building would be 15 feet tall and would provide approximately 900 square feet of floor area. The portable building would be used for the Building Department, Public Works Department, and Planning Department.
