RESOLUTION NO. 1977

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF ROSS CERTIFYING THE RESULTS OF THE MUNICIPAL ELECTION HELD IN AND FOR THE TOWN OF ROSS, STATE OF CALIFORNIA, ON NOVEMBER 8, 2016

WHEREAS, a General Election was held and conducted in the Town of Ross on Tuesday, November 8, 2016 to consider continuing the public safety tax in the Town; and

WHEREAS, it appears that notice of said election was duly and legally given, that consolidated precincts were properly established, that election officers were appointed and election supplies furnished, and that in all respects said election was held and conducted, and the votes cast thereat received and canvassed, and the returns thereof made and returned in time, form and manner, as required by the Election Code of the State of California providing for and regulating of elections in cities; and

WHEREAS, the Town Council of the Town of Ross has received the Canvass of the Vote for this election from the Marin County Registrar of Voters and is attached as "Exhibit A".

NOW, THEREFORE BE IT RESOLVED, the Town Council of the Town of Ross does resolve, declare, determine and order as follows:

- 1. That the whole number of ballots cast in the Town of Ross in said election was 1,463 which comprised 89.59% of the registered voters (1,633);
- 2. That Measure "K" a Public Safety Tax, was voted on at the November 8, 2016 election, with the following results:

Measure	<u>Yes Votes</u>	No Votes	
Public Safety Tax – Measure K	1,097 (78.69%)	297 (21.31%)	

- 3. That as a result of the election, the "Yes" votes received on Measure K did meet the two-thirds majority vote required, and therefore passed.
- 4. That with the passage of Measure K, the Public Safety tax will take effect on July 1, 2017, and continue for eight years until June 30, 2025.


