Subject: Confirmation of Key Executives and Signature Authority for the Town of Ross

Checking Account and Re-confirmation of Administrators for Town of Ross Wells

Fargo Credit Card Accounts

Recommendation

It is recommended that the Town Council approve a letter to Wells Fargo confirming Key Executives and Signature Authority for the Town of Ross' Wells Fargo checking account and reconfirm appointing the Town Manager and Town Clerk/Administrative Manager as Administrators for the Town of Ross Wells Fargo credit card accounts.

Background and discussion

Wells Fargo provides the Town of Ross with banking services. A recent review by Town staff determined that the Wells Fargo maintained list of the individuals identified as "Key Executives", "Signature Authority", and "Administrators" for the Town's Wells Fargo account requires updating. It was also requested by Wells Fargo that the Town re-confirm who would serve as administrators for the Town of Ross credit card accounts to make needed changes from time to time. The Town received instructions on how to remedy this situation and at the September 14, 2023 Council Meeting, Resolution 2332 appointing the Town Manager and Town Clerk/Administrative Manager as administrators for the Town of Ross credit card accounts was approved unanimously. For the reasons stated above, an additional letter listing Key Executives, Signature Authority and reconfirming Administrators was requested by Wells Fargo.


