**Recommendation**

Each year, the Town Council reviews and updates its committee assignments list for the new fiscal year. The attached list shows current Town of Ross committees and the primary and backup assignments to them with positions highlighted that require Town Council consideration. Information is also provided below to assist the Town Council in its appointment process.

**Town Council Subcommittees**

Community Protection

Meetings are scheduled as needed.

Finance

Meetings are scheduled as needed.

General Government

Meetings are scheduled as needed.

Public Works

Meetings are scheduled as needed.

**REVISED Other Boards/Committees Requiring a Ross Councilmember**

Association of Bay Area Governments (ABAG)

Meetings are scheduled quarterly in San Francisco starting at 10:30am with a business meeting. Lunch is served with a presentation and networking following. Many people leave after the business meeting unless the presentation is controversial. Meetings can run until 3:00pm.

Marin Clean Energy Board of Directors (MCE)

Meetings are scheduled monthly on the third Thursday in San Rafael starting at 6:30pm with dinner. Meetings can run until 8:30pm or 9:00pm. Sometimes meetings are “released” (canceled).

Marin Wildfire Prevention JPA Board of Directors

Meetings are scheduled monthly on the third Thursday in San Rafael starting at 3:00pm. Meetings run until 5:00pm. Zoom is available. Meetings can be offsite (vegetation management project locations throughout Marin). Prep and follow up time can be up to 15 hours per week.

MCCMC MarinCAN (new committee, successor of Drawdown Marin)

Meetings are scheduled monthly on the second Wednesday at the Marin Clean Energy Office in San Rafael or via Zoom starting at 4:00pm. Meetings usually run until 6:00pm.

MCCMC Legislative Committee

Meetings are scheduled every other month on the fourth Monday at San Rafael City Hall starting at 8:00am. Meetings usually run for one hour. Next meeting is scheduled for May 27.

MCCMC Climate Action Committee

Meetings are scheduled monthly via Zoom for one hour. Meetings are currently on hold as the group does not have a chair.

MCCMC City/County Services Committee

Meetings are no longer being held.

MCCMC Homeless Committee

Meetings are scheduled monthly on the second Thursday starting at 6:00pm. Meetings usually run 1-1/2 hours and are currently held via Zoom.

Ross Valley Fire Department Board of Directors

Meetings are scheduled monthly on the second Wednesday at Town Hall in San Anselmo at 6:30pm. Meetings can run until 9:30pm and are available on Zoom. Prep work can range from 30 minutes to a few hours.

Ross Valley Paramedic Authority Board of Directors

Meetings are scheduled quarterly, plus May on the first Thursday in Corte Madera starting at 6:30pm. Meetings usually run 1-2 hours. Prep work can range from 30 minutes to a few hours.

Safe Routes to School Task Force

Meetings are scheduled quarterly, during the daytime, via Zoom and can run 1-1/2 hours.

Transportation Authority of Marin (TAM) Board of Commissioners

Meetings are scheduled monthly on the fourth Thursday at the Marin Supervisors chambers at 4:00pm for the TAM Countywide Transportation Plan (CTP) Board Workshop and 6:30pm for the Board of Commissioners. Meetings usually run 2-3 hours. The next meeting is Thursday, April 25, 2024.

## **Revised Committees that do not require a Councilmember**

### Ross Ready (formerly DISCO)

Gil Fleitas currently represents the Town Council on this committee.

### Flood Zone 9 Advisory Committee

The Town Council's current representative, Chris Martin, has expressed interest in continuing in this role. See attached correspondence from Mr. Martin. The Committee meets irregularly, typically quarterly.

### Marin County Commission on Aging

Teri Dowling currently represents the Town Council on this commission. Diane Doodha has expressed interest in the appointment.

Meetings are scheduled monthly on the second Monday in San Rafael with a presentation at 1:30pm and the business meeting at 2:35pm. Meetings can last up to three hours. Depending on the committee assignment, prep work and follow up can range from one to 20 hours.

### Marin Emergency Radio Authority (MERA)

The Town Council's current representative, Tom Gaffney, has expressed interest in continuing in this role. See attached correspondence from Mr. Gaffney.

### Marin/Sonoma Mosquito and Vector Control District Board of Directors

See attached letter. The Town Council is not required to appoint a representative to this board. The Town's representative, Monique Predovich resigned. The term is 2 or 4 years.

### Hazardous & Solid Waste JPA Board of Directors

Town Manager Christa Johnson represents the Town on the JPA Board.

Meetings are scheduled 3-4 times per year at different locations at different times depending on the availability of participants.

Dear Town Clerk:

Currently, the Town of Ross does not have a representative on our District's Board of Trustees. While it is not mandated that you appoint a representative to our Board {California Health and Safety Code, Division 3, Chapter 1, Article 3, Section 2022 (d)}, it is the intent of the Legislature that persons appointed to Boards of Trustees have experience, training, and education in fields that will assist in the governance of the District.

The following information is sent to assist your elected officials in the appointment process. California Health and Safety Code:

*Section 2022 (a) Each person appointed by a board of supervisors to be a member of a board of trustees shall be a voter in that county and a resident of that portion of the county that is within the district.*

*Section 2024 (a) The term of office for a member of the board of trustees shall be for a term of two (2) or four (4) years at the discretion of the appointing authority.*

*Section 2023 (c) At the first meeting of the initial board of trustees, the trustees shall classify themselves by lot into two classes, as nearly equal as possible. The term of office of the class having the greater number shall expire at noon on the first Monday in January that is closest to the second year from the appointments made pursuant to Section 2021. The term of office of the class having the lesser number shall expire at noon on the first Monday in January that is closest to the first year from the appointments made pursuant to Section 2021.*
