New Council Member Appointed

At a special Council meeting on December 6th, the Town Council appointed Julie McMillan to fill the Council seat vacated by Katie Hoertkorn. The Council received a total of eight applications for the Council seat, and ended up only interviewing four candidates, as four of the applicants withdrew their application. It was encouraging to see so many enthusiastic residents interested in serving on the Council. Thank you to all who applied for the Council seat.



Julie McMillan Council Member

Julie McMillan moved to Ross with her husband, Tim Baughman, in 1992. After graduating from UCLA and Stanford Law School, Julie practiced complex litigation at O'Melveny & Myers until 1999. All three of her children graduated from Ross School, where Julie was elected to the School Board (2003-07) and served as Capital Campaign Chair (2006-10), Endowment President (2001-04), Foundation President (2002-03), and Margie Burke Speech Tournament Chair (2011). Julie was also President of Ross Parks and Recreation (2001-02) and campaigned for the last two Ross Parcel Tax Measures. She has held leadership positions in other Marin County schools and nonprofits, including at The Branson School, Redwood High School, Family & Children's Law Center (2003-08), Sunny Hills Services (2003-09), Ross Valley Women's League (2001-04), National Charity League, Marin Chapter (2008-14), and Bridge The Gap College Prep (Marin City) (2017-).



Julie will serve from December 2017 to June 2018. She was officially sworn in at the December 14th Council meeting.

There will be a Council election on June 5, 2018, to fill the seat remaining two-year term of Katie Hoertkorn, as well as two (2) four-year terms which are expir-

ing (those of Mayor Robbins and Council Member Rupert Russell). Further information on the June election process for running for Council, will be announced in late January 2018.

The Council held a special meeting on December 6 to select a new council member to replace Katie Hoertkorn, who stepped down last month for health reasons. Eight residents submitted applications; all

were extremely well qualified. After reviewing applications prior to the meeting and interviewing candidates during the meeting, council members selected Julie McMillan to fill the vacant seat. Julie is well known for her work on numerous boards and committees in Ross and in the larger community, and served on the Ross School Board from 2003-2007. Councilmember McMillan's appointment runs from December 2017 through June 2018. In June 2018 there will be three council seats up for election: a two-year seat, currently held by Julie MacMillan, and two four-year seats, currently held by Rupert Russell and Elizabeth Robbins. In 2020 the usual four-year terms for all seats will resume: there will be three four-year council seats up for election.

Corte Madera Creek Flood Control Project Update

Last night the Town Council passed a resolution acknowledging the potential flood control benefits of the Marin County Flood Control District's Corte Madera Creek Flood Risk Reduction Project Phase One and continuing with development of the conceptual plan. The project consists of removing the fish ladder in the creek behind the Post Office parking lot, and over 800 feet of concrete channel along Frederick Allen Park. The creek corridor along the park would be widened, and flood barriers (walls or earth berms) would be constructed to prevent floodwaters from overtopping the

creek during the larger storms. The project will require a complete reconstruction and revegetation of the mid-portion of Frederick Allen Park, but it will also provide new public access opportunities along the newly restored creek bed during most of the year. The wide swath of publicly-owned land in this area allows for the design of a smooth and hydraulically efficient transition back to the concrete channel next to the tennis courts, an option that was unavailable to the Corps of Engineers when the project ended abruptly at the fish ladder back in 1971. The passing of the resolution gives a nod to the Marin County Flood Control District to proceed with further project design and development through the preparation of the environmental



impact report and is an important first step in bringing the project closer to the completion deadline of June, 2020. The Town Council and staff will have additional opportunities to review the project during the Design Review public hearing process with Town Council vote on the detailed Design Review and all agreements with the Flood Control District in late 2018 or early 2019.

2) **Tree Ordinance**. The Town of Ross has a long history of being proactive regarding the



protection and maintenance of our extensive and beautiful tree canopy. This ordinance (Ross Municipal Code Chapter 12.24) which was last updated in 2015, has expanded over the years to provide the structure for regulating the removal of trees through the issuance of a "Tree Alteration or Removal Permit" and allows

for a tree removal permit applicant to pay an "in-lieu" fee to the town under certain circumstances, instead of planting a replacement tree. On November 9, 2017 the Town staff received direction from the Town Council to amend the ordinance to clarify when a tree is being removed due to it being a hazard to a physical structure, and reduce the in-lieu fee for such cases. Other minor ordinance changes include bringing the regulatory responsibility for tree removal back to the Public Works Department and provide some flexibility to the Town on how the in lieu fee revenue can be spent.

3) Recreational Vehicle (RV) Parking Within Town Limits. The Council approved prohibiting parking of RVs on public streets and right-of-ways within the Town. The ordinance also limits RV parking on private property to the following:

New Ordinances Introduced

Three new ordinances were introduced at the December 14th Council meeting. Here is a brief summary of each:

1) **Smoking Regulations**. At the October 12th Council meeting, Council directed staff to amend the



current Smoking Regulations to address new and existing multiunit residences, regulating the sale of tobacco products, adding new definitions such as bar, child care facilities, electronic smoking device, recreational

area, etc., and prohibiting smoking on active construction sites. The smoking regulations have not been updated since 2007.

Holiday Shopping

1) must be parked in the driveway; 2) must be set back a minimum of 15 feet from the roadway edge; 3) may

not be parked longer than 3 days, unless the owner has erected a fence or screening (subject to Town approval) that substantially blocks the view from public view; and 4) no living quarters shall be maintained



or business conducted within a parked or stored RV. ■
