Joe, Public Works Director Rich Simonitch, Public Works Maintenance Worker Anthony Alcozer, Police Chief Masterson and the Police officers, the firefighters, and Linda Lopez spent the weekend on duty, with Anthony and Chief Masterson sleeping at the Town offices. Rich and Anthony monitored drainage issues, both for the Town and private property owners. While our neighboring towns ran out of sand, we had adequate sand, thanks specifically to

## Winter Storms & Flood Preparedness

The recent rains have taught us one thing: you really can't predict what Mother Nature is going to do. Three storms over the last several weeks have forecasted the real possibility of the Corte Madera Creek (which runs through Ross) overflowing its banks. Two of the storms came dangerously close to overflowing, but at the eleventh hour the rains eased, and the creek receded. With the last storm, the creek did crest on parts of Sir Francis Drake, but overall we were very lucky. The recent storms have given the Town good practice runs on our emergency preparedness. What are we doing right and what can we improve on. Preparing for storms is a part-

nership between the Town and residents. It is important that property owners maintain all watercourses and drainageways that pass over, under, and in many cases around their private property, including the cul-

vert under your driveway and walkway. Please keep these facilities clean and free of debris that can obstruct the natural flow of water. Also, inspect your trees, dead or dying trees fall during storms and routinely take down power lines, damage property, block roadways, and sometimes injure people. If you need a tree removed, please come down to Town Hall and get a tree removal permit. We were fortunate the last

series of storms not to have any major power outages, which were common in communities all around us.

Here are some actions/steps residents can take to prepare themselves for a flood emergency:

- 1) Subscribe to the Town's Email list to stay informed of Town emergency notifications. We do not share your email address with anyone. Click here to join.
- 2) Register your phone with "Alert Marin" to receive emergency phone notifications sent from the County of Marin. Click here to register. 3) Make an emergency plan for you and your family.

Anthony's actions. Additionally the Police continuously re-stocked the sand bags at Natalie Coffin Greene Park. Truly Measure K in action!

This past Tuesday night we came even closer to flooding. While the water went over on parts of Sir Francis Drake, and some of the streets were flooded, overall we escaped a serious situation, and once again Town staff, Public Works and the Police were out in full force.

Flood control is a partnership between the Town and all of the residents. We need you to make sure that your drainage ditches and culverts are cleared regularly and remain free flowing. We also need you to keep your trees pruned, eliminating dead wood, as well as clearing any dead trees. PG&E has been very active trimming trees



away from power lines all season long. Importantly, no trees fell during these two storms that knocked out electrical service or closed or blocked a roadway.

I also want to recognize everyone who attended or wrote regarding December's meeting concerning the Ross Commons, employee housing and park issues. While it can be emotional, it is gratifying that we are a full throated democracy, and I think the belief that we all have a voice in the Town's future is one of the major reasons Measure K had such overwhelming support. I hope that we continue to have diverse comments on the important issues that come before Council.

- 4) Prepare an emergency supply kit. Do you have supplies to sustain you for 72 hours?
- 5) Have an evacuation plan in place. Depending on the emergency, you may have to evacuate to a safe location. Where will you go and what route will you follow?

The <u>Emergency Preparedness Guide</u> available on the Town's website, offers useful checklists, information on what to do in an emergency and resources to guide you through it.

#### Flood Warning Siren

The <u>Corte Madera Creek level</u> in Ross is monitored closely during heavy rainfall. The Town works in conjunction with the Towns of San Anselmo and Fairfax to sound the siren when there is imminent danger of the creek overflowing its banks. When the siren is sounded, residents and merchants are advised to proceed immediately to higher ground, and to stay away from the creek during this time as it can be very dangerous.

#### Safety Tips

- Do not walk or drive through flood waters. Water can be deeper than it appears and water levels rise quickly.
- J Stay away from moving water. Just 6 inches of moving water can knock you

down, and 2 feet of water can sweep your vehicle away.

- If your home is flooded, turn the electricity off until emergency officials tell you it is safe to turn it on.
- Stay away from downed power lines and report to PG&E immediately.
- Stay alert and listen to your local radio or television for weather report updates.

The Town's website contains numerous resources to assist you in preparing for an emergency. We want everyone to be safe and prepared for an emergency.

## **Reminder from the Ross Post Office**



The Ross Postmaster would like to remind residents of the following regarding mail:

 All outgoing mail should always have a PO Box listed on it;

it's fine to also list the street address, but you must have the PO Box in the address.

 2) For mail that requires a physical address as well as packages, use the following format: Name
 123 Elm Street/#9345
 Ross, CA 94957

In this example the 9345 is the PO Box number.

3) Help the Post Office out and break down cardboard boxes before putting them in the bin, so the bins can accept more discarded mail.

# Marin Sanitary 2017 Rates



The Council approved the Marin Sanitary rate increase of 5.71% for 2017. The Town is part of a

franchisor's group comprised of San Rafael, Larkspur, portions of Marin County and the Las Gallinas Valley Sanitary District. This group in turn retains an independent consulting firm to review the rate package submitted annually by Marin Sanitary Service (MSS). This year, HF&H Consultants, LLC has determined a 5.71% rate increase is appropriate for the Town to compensate MSS for its costs to provide refuse and related services based on the agreed to methodology used in our contract.

The cost of a 32 gallon residential landfill cart would be increased approximately \$1.85 per month, from \$32.37 to \$34.22. The average for all of Marin is \$35.46 and the Bay Area average is \$34.15.

While perhaps the original purpose of refuse service had to do with public health and safety around sanitation, it is increasingly emphasizing making progress on waste reduction and climate change goals. The State of California has adopted several pieces of legislation mandating significant reductions of waste to landfill. Marin County has a current diversion rate of 74%. MSS and other organizations are putting considerable time and effort into getting organics out of the landfill. The Commercial Food to Energy (F2E) program and new statewide legislation, AB1826, which mandates commercial composting are expected to increase the diversion rate.





# Bolinas Avenue Drainage Project

The Council authorized the Town Manager to execute an agreement with the Town of San Anselmo to share consultant fees and project oversight associated

with the Bolinas Avenue drainage improvement project plan. Over the past several years the drainage issues on Bolinas Avenue have been the focus of independent hydrological evaluations by consultants working under contract by both the Towns of Ross and San Anselmo. The desire now is to proceed with a plan of action to design adequate drainage facilities within Bolinas Avenue to relieve "nuisance" flooding. Following the drainage design being complete, it is the intent to put it out to bid as soon as possible so that much needed pavement rehabilitation for Bolinas Avenue can occur immediately after the storm drain undergrounding is completed.

The Town of San Anselmo will act as lead agency for the drainage improvements, and the scope of work will be divided into 2 phases.

# **Good Neighbor Reminder**



#### **Trash Day**

The Town's Municipal Code requires that all garbage cans/recycling containers be stored out of public view except on trash pick-up day. Please promptly remove your trash containers from the street after garbage pick -up. Ross Municipal Code Section

<u>6.12.140</u>, states "No refuse and/or recyclable materials receptacle other than those owned or rented by the town shall be placed or kept in or on any public street, sidewalk, footpath, or any public place whatsoever, but shall be maintained on the premises, out of public view, except as may be provided for removing and emptying by the authorized refuse and recycling agent on the day(s) and in the location designated for collection."
