Proposal to Transfer Ross Preschool

The Town of Ross has received a proposal to transfer the operation of the Ross Preschool from the Town to a non-profit under the direction of the current Preschool Director, David Hughes. The potential benefits of operating the preschool through a non-profit include increased staff hours, establishing an aftercare program and expanding the current program. Due to part time staff restrictions, the current program is unable to offer aftercare nor increase the current staff hours. The plan is for the preschool to remain located at St. John's Church with the existing preschool teachers to remain as teachers following the proposed transfer.

Ross preschool has existed since the 1950's under various sponsors including Ross Recreation. The proposal seeks to continue the tradition of the preschool and add enhancements that will further improve this dynamic learning experience for preschool children.

The Town Council will consider approval of this proposal at the April 5th Town Council meeting. If approved at the April 5th Council meeting, the preschool would transfer August 1, 2018. Last month's Mayor's Report mentioned that PGE is proposing to replace Ross's street lights with LED lights, which use less electricity and require less frequent replacement. Many residents have shared concerns about this proposal with council members. Concerns are focused primarily on the excessive brightness of LED lights and the unattractive blue/white hue to the lights. The Town of Ross has requested that PG&E do a small

pilot installation of LED lights before any town-wide replacement is considered. The town is waiting to hear from PG&E about when and where the trial lights would be installed.

Town Bids Farewell to Long-Time Staff Member

The Building and Public Works Department is losing a familiar face that countless residents and contractors have been greeted by at the public counter for many years. Long-time employee, Simone Jamotte, is retiring after 23 years of service. She began working for Ross in 1994, as a part-time member of the Building and Public

Works staff. Through the years, her job expanded to take on more duties and tasks to keep up with the ever-changing times. Simone has issued thousands of building permits over the years and has probably



processed a permit for most residents in Town at one time or another. In her 23 years, she has worked with numerous supervisors and seen 25 residents serve as Council members.

February 15 Annual Council Workshop Highlights

The Town Council and staff had their annual Strategic Workshop on February 15. We made great progress on a number of issues as we move forward with specific projects, including the five year financial forecast and five year Capital Improvement Plan (CIP). The Town Council affirmed the current six Town goals, which are: 1) sustain financial responsibility and stability, 2) enhance effectiveness and efficiency of delivery of services, 3) maintain a safe community, 4) foster and strengthen community involvement, 5) improve infrastructure and facilities, 6) provide transparency and consistency in government.

Some of next year's projects to be completed include: preschool potential change in service delivery; pavement rehabilitation and drainage improvements in several locations in Town; downtown revitalization and zoning review; implementing new Planning and Building permit tracking software; developing detailed Design Guidelines; continue with Zoning Ordinance cleanup and amendments; review of Civic Center site to determine facilities to construct/rehabilitate; new recreation programs (to name a few).


Council Discusses WUI

Catastrophic wildfires, such as the 1991 Oakland Hills fire and most recently the 2017 Sonoma and Napa fire, that impact human communities have become increasingly common in recent years. Wildland fire protection for the Town of Ross is regulated by the State of California for those properties that are located within a Very High Fire Severity Zone and by local regulations for properties that are located within a Wildland Urban Interface (WUI). A WUI is defined as an area where houses meet or intermingle with undeveloped wildland vegetation. A property that is mapped as being within a WUI is required to comply with the California Fire Code related to "Defensible Space" and vegetation management, in addition to compliance with the California Building Code or the California Residential Code WUI construction requirements, which includes fire rated building materials (also known as the "Hardening of Surfaces"). Defensible Space refers to an area 100 feet around the perimeter of structures or developments with the purpose of managing flammable vegetation to reduce the potential for the structure and/ or structures to ignite in the event of a wildfire. The intensity of fuel management is prescribed by Public Resources Code 4291 and varies with the feet from the structure being the most important. The Hardening of Surfaces referrers to materials and construction methods, such as tempered windows, metal gutters, and fire resistant exterior decking material. From a local government perspective, the Town of Ross' Municipal Code references WUI regulations in Chapter 18.39, Hillside Lot Permit, Chapter 12.12, Weeds, Trees, and Vegetation, and Chapter 14.04, Fire Code. Relative to a Hillside Lot Permit, WUI compliance is required for properties that are classified as Hillside Lots (e.g., has a 30% or greater slope or partially or wholly located within a Slope Hazard Stability Zone 3 or 4) and for projects that trigger a Hillside Lot Permit. For example, a Hillside Lot Permit would be

required for a project that would include a 200 square foot new floor addition area on a property has that slope of 30% or greater. addition The would need to comply with



the California Fire Code regarding defensible space and vegetation management, in addition to complying with either the California Building Code or California Residential Code WUI construction requirements.

Chapter 12.12, Weeds, Trees, and Vegetation, of the Ross Municipal Code requires property owners to comply with defensible space requirements for those properties classified as a Hillside Lot as previously described.

Chapter 14.04, Fire Code, of the Ross Municipal Code, requires conformance of WUI regulations for those properties that are designated as being located within a Town Council approved WUI map, however, a WUI map has yet to be adopted by the Town Council. As such, at last night's meeting, the Town Council considered three WUI Map options as follows: (1) not adopting a map; (2) adopting a map that would include all Hillside Lot and parcels that are geographically connected to the Hillside Lots; or lastly, (3) a map that would include the entire Town or a map that would include the entire Town less the Ross Common, the Ross School, and the downtown. The Council directed staff to pursue a Municipal Code amendment to Chapter 14.04 in favor of Option 2. Staff will come back to the Town Council at a future Council meeting to approve the WUI map and related code amendments that correspond to Option 2. ■



Online Survey Seeks Input on Pollution



The Marin County
Stormwater Pollution
Prevention Program
(MCSTOPPP) is asking
residents to complete an
online Stormwater
Pollution Prevention
& Awareness Survey
to help understand the

public's awareness of potential pollutant-generating activities in Marin County. MCSTOPPP conducts education and outreach to residents to prevent pollution from getting into the storm drains, which flow directly to waterways. The newly released short survey will help MCSTOPP identify gaps in public knowledge about practices that generate pollutants, hurt water quality, and threaten wildlife that depend on healthy water. The results of the survey will allow MCSTOPPP to target outreach where it is most needed. One of the big contributors to stormwater pollution is pet waste that is improperly disposed and is picked up by stormwater runoff and washed into storm drains or nearby water bodies. By picking up after your pet, you can help protect our local creeks, wetlands, bays and ocean.
