Our newest member, Julie McMillan, has dived in with service as our representative to the Association of Bay Area Governments, the County Homeless Committee, and to the Legislative and Disaster Preparedness Committees of the Marin County Council of Mayors and Council Members (MCCMC). Julie is our expert on disaster preparedness, working with resident Gil Fleitas on our Town Disaster Preparedness Council. Elizabeth Robbins is our representative to the board of the Marin Telecommunications Agency. She also serves on the MCCMC Pension Reform committee and as our liaison to the Ross Property Owners Association. Rupert Russell, who greeted the rest of us as we joined the Council, serves on the board of the ever-expanding Marin Energy Authority and is our liaison to the Marin Art and Garden Center. Elizabeth Brekhus, our Mayor Pro Tem, is currently the vice-president of MCCMC and chair of the Board of the Ross Valley Fire Department.

I serve as a commissioner of the Transportation Authority of Marin, on one of its executive committees, and on its Alternative Fuel and Electric Vehicle committee, as a member of the Ross Valley Fire Department Board of Directors and as the Council's liaison to the Town's Leadership Council.

### **New Ross Valley Fire Chief**

At its July 11th meeting, the Ross Valley Fire JPA Board approved the contract to share management services with the Marin County Fire Department and to have Marin County Fire Chief Jason Weber serve as

Chief of Ross Valley Fire effective August 1st. Chief Weber replaces Acting Fire Chief Roger Meagor, who returned from retirement to help oversee the recruitment of a new Fire Chief. We thank Chief Meagor for his service and assistance in this recruitment and wish him the best in his second chance at retirement!

Chief Weber has provided firefighting skill and leadership to the Marin County Fire Department for over 23 years. He has served in the Department in all ranks, starting as a Seasonal Firefighter to being appointed Fire Chief in March 2012. Chief Weber holds an Associate's Degree in Fire Science, a Bachelor's Degree from California State University Long Beach, and Chief Fire Officer's Certification from the State Fire Marshal's Office. He currently serves on the California Fire Service Task Force on Climate Impacts and was recently appointed as Chair of the California Wildfire Coordinating Group. Welcome Chief Weber!

### **September is Preparedness Month**

The U.S. Department of Homeland Security sponsors a National Preparedness Month each September to encourage Americans to prepare for emergencies and to increase public awareness of its importance. A major disaster such as an earthquake, flood, wildland fire,

public health crisis, or terrorism, could strike at any time. Do you have a plan for all types of emergencies? Are you and your family prepared for the crucial 72-hour period after a disaster where community pre-



paredness is key to survival? The Council passed a resolution proclaiming September as Community Preparedness Month to remind residents how vital it is that everyone take steps to prepare for emergencies at home, work or school. Personal preparedness and planning in advance is critical to effectively respond to a disaster.

There are a number of things residents can do to prepare: I) The recently adopted Ross Wildland Urban Interface (WUI) map is currently in effect, and with fires still raging in Northern California, residents locat-

### Approves LED Street Lights



The Council approved to opt-in to the Pacific Gas & Electric (PG&E) LED street light replacement program and directed staff to commence with the replacement of the existing conventional street lights with LED technology at no cost to the Town.

The purpose of the program is to save energy and reduce greenhouse gases. In addition, adequate street lighting is an essential safety feature for the community and for vehicle and pedestrian travel at night. PG&E identified 206 street lights throughout Town as being eligible at no cost for the standard LED installation. Over half of these lights are outdated and highly inefficient incandescent bulbs. Replacement of the lights will average an 80% reduction in energy consumption. Energy cost savings to the Town is estimated at \$7,000 annually, and the long 20-year life of LED street lights will reduce outage time and maintenance calls. Ross is one of the last municipalities within PG&E's jurisdiction that doesn't have LED street lights, but one of the first to be offered the "softer" style (2700K) LED fixtures.

On July 16th, PG&E installed eight LED street lights on a trial basis: five 2700K street lights along the Winship-Garden-Wellington loop; and three 3000K street lights on Lagunitas Road between Ross Common and Allen Lane. The two different locations were selected to evaluate lighting levels for different neighborhood scenarios. Residents were encouraged to evaluate the effects that the new lighting had on the neighborhood streets and walkways and provide feedback to town staff, who will continue to monitor resident's reaction as the townwide implementation begins later this year.

# Public Safety

The Ross Police Department requested permission to install a Vehicle

Speed Feedback
Sign on Sir Francis
Drake Boulevard entering the Town from
San Anselmo. These signs are used to provide information to drivers of their current speed. Studies have shown these types of devices can slow vehicle speeds by as much as 10%.



The Police Department has received complaints about drivers speeding as they enter the Town, while the road transitions from two lanes into a single lane as it travels through an "S" curve. There have been accidents attributed to speed in this area.



The lighted speed sign would be placed in conjunction with the posted speed limit sign. It will be set to alert drivers that are exceeding the safe speed in that area.

### **New Ordinances Adopted**

The Council adopted three ordinances at the September meeting: 1) Social Host Ordinance (§9.60) - this chapter was formerly called "Underage Drinking", the ordinance title was changed and regulations governing loud and unruly gatherings were updated; 2) Purchasing (§2.38) and Public Projects (§2.40) - Two new chapters were added to the Municipal Code regarding the purchasing of supplies, services and equipment, and informal bidding procedures for public projects under the Uniform Public Construction Cost Accounting Act; and Wireless **Telecommunications** (§18.55) - A new chapter added to provide a uniform and comprehensive set of regulations and standards for the permitting, development, siting, installation, design, operation and maintenance of wireless telecommunication facilities in the town.
