The holidays are here and a new year is around the corner. Everyone has had an extraordinary 2020, with COVID-19, a recession, racial justice issues, wildfires, climate change, and now another Stay

Home Order. It's hard to believe that the Town Council has not met in person for more than nine months, and we truly miss seeing our colleagues, staff and residents. Despite these challenges, our Town continues to move forward. This year we took the following actions: 1) COVID-19 pandemic Health Order measures to keep the community safe and assist business and school operations; 2) Participated in and supported the start -up of the Marin Wildfire Prevention Authority; 3) Approved the Winship Bridge

Community Questionnaire Seeks Input



Have you completed the Ross Town facilities community questionnaire? The Town needs your feedback. Our public safety building which was originally constructed in 1927 is physically and functionally obsolete, with exten-

sive structural deficiencies, and is not compliant with Essential Service Act requirements for public safety buildings. Decisions needs to be made on how best to modernize the Town's facilities and we are seeking input from residents. Please complete our brief online questionnaire using the following link:

The questionnaire should take less than 5 minutes to complete and responses will be accepted through December 23, 2020. The purpose of the questionnaire is to inform the Town Council as it considers the Town facilities modernization project and determines its scope early next year as part of the public planning process. New COVID-19 Stay Home Order

With COVID cases continuing to spike, the County's new health order that went into effect December 8th orders Bay Area residents to stay at home as much as possible and limit mixing with other households. This is especially hard now due to the holidays in a year that has already been extremely challenging for everyone. We look forward to a time when things return to some kind of normalcy. Please continue to follow the health order and stay safe during the holidays.

With the new Order, more restrictions have been put in place until January 4, 2021, such as retail operations reduced to 20% capacity, and restaurants offering only take-out. A number of business sectors were ordered to close such as gyms, hair salons and barbershops, wineries, bars, movie theatres, and amusement parks. Playgrounds are now allowed to remain open to facilitate physically distanced personal health and wellness through outdoor exercise. Replacement mitigated negative declaration; 4) Adopted the West Ross Undergrounding Utility District #I boundary map and began the engineering work; 5) Provided input on the Corte Madera Creek Flood Risk Management Project; 6) Prepared for PG&E power shutdowns, including adopting a policy on generators; 7) Maintained a balanced budget in challenging times, while providing significant funding for current and future capital improvements; 8) Rehabilitated Bolinas Avenue and Thomas Court streets; 9) Resurfaced the Frederick Allen Park tennis courts; 10) Completed landscape improvements to the 6 Redwood site, connecting it to the Common for public use, and added picnic tables along Redwood Drive; 11) Continued discussions on how best to modernize Town facilities for fire, police, paramedics and administrative staff (*Thank you for returning your facilities questionnaire by December 23:* https://www.surveymonkey.com/r/rosspublicsafety); and 12) Continued addressing climate change.

Next year promises to be just as busy. In early 2021, items on our agenda include: I) Town facilities: We will determine which facilities to rebuild; 2) Sir Francis Drake Boulevard: Along with other jurisdictions, we will decide whether to rename the street; and 3) Ross Common Landscaping Master Plan: We will consider new design concepts.

Ross Police Chief to Retire

Police Chief Erik Masterson has announced his plans to retire in March/April 2021. Chief Masterson's distinguished career has spanned over four decades in law enforcement with 30 years with the City of San Rafael, 1.5 years in the Town of San Anselmo, and the last 10 years with the Ross Police Department as

Police Chief. During his tenure, Chief Masterson has led the department with impeccable character and integrity, the highest standards of excellence, and a deep commitment to providing effective community policing to ensure Ross remains one of the nation's safest. Always approachable, Chief Masterson's generous spirit and calm demeanor, and his willingness to engage and interact with the community, have been the perfect fit for Ross. He will be very hard to replace and greatly missed!

The Town has begun its recruitment process for the new Chief of Police, and hopes to begin interviews early next year.

Marin Wildfire Prevention Authority Update



Mark Brown Executive Officer

Mark Brown was introduced at the December Council meeting as the new Executive Officer of the Marin Wildfire Prevention Authority (MWPA). Mr. Brown started his career in the fire service in 1986 and was hired at the Marin County Fire Department in 1991 as a Firefighter/Paramedic. He retired as the

Deputy Fire Chief in order to transition into the role of Executive Officer for the MWPA.

The MWPA was funded through Measure C that was passed by the voters of Marin County on March 3, 2020. Measure C has allowed MWPA to considerably expand prevention efforts around wildfire protection. This includes providing on-site evaluations to property owners. Beginning in May this year, MWPA dispatched nearly 20 seasonal employees to meet with homeowners and assist them in creating adequate defensible space around their home and ways to "harden" the home to protect from ember showers.

To date, the following projects have been completed or are currently in the works throughout the County:

Vegetation Management: includes 3 Chipper Days held in Ross.

Evacuation Route Clearing: Baywood, Wellington, Madera, Crest completed, and evacuation clearing work currently occurring on Upper Road, Woodhaven, and early next year on Upper Road West.

Evacuation Planning/Improvements: Currently drafting a Request for Proposals for an Evacuation Route Study; Evacuation Route Maps for the community - a future project for MWPA to round out the entire county.

Notification Systems Improvements: 1,000 NOAA Weather Radios distributed throughout Marin.



Public Education: 7 Webinars with 6,075 people in attendance; 4

Informational newsletters sent to 4,500 subscribers; 102,000 FireSafe Marin website visitors (87% are new visits); Educational materials distributed (Wildfire Preparedness Brochure, Evacuation Checklist, Firewise Door Hangers); 15 educational videos completed.

Defensible Space Evaluations: 11,929 Defensible Space Evaluations were conducted countywide, including 474 in Ross.

The primary goals of the MWPA are to: I) Protect lives; 2) Protect homes and structures from loss; and 3) Create a landscape that allows for lower intensity fire. Protecting people's lives focuses on a "house out" approach, meaning we are placing considerable emphasis on homes being a defendable place in a wildfire, and improving evacuation routes to ensure residents can rapidly and orderly evacuate in the event of a wildfire. This year, MPWA has focused efforts on evacuation routes in some of the town's most vulnerable hillside areas.



Right Place

UC Marin Master Gardeners always say to plant the "right plant in the right place" as a formula for success. In a fire-

smart landscape there are no fire resistant plants, since all plants can burn. Plants should be water wise and ecologically sound, well main-



tained and in good health. Add proper irrigation and maintenance, and keep them free of dead material and fallen leaves.

- For easy maintenance and water savings, a good choice are California natives.
- Choose pollinator-friendly, summer dry and winter wet plants for our Marin Mediterranean climate.
- Create a mosaic, a patchwork of plants within the garden.
- Ensure the separation of shrubby bushes, perennials and groundcovers using the right mulch, rock or pavers.
- Ensure fire-smart spacing of shrubby bushes by regularly pruning
