Ross Age-Friendly Data Released

Teri Dowling, the Town's Age-Friendly representative, presented to Council information from two reports that the County recently released on older adults in Marin County: 1) 2019 County of Marin Area Agency on Aging Older Adults Needs Assessment Study (*this report will be released in the coming months*); and (2) [2020 County Age Friendly Report](#) which focuses on recommended actions to be taken over the next several years to support an Age-Friendly Marin.



By 2025, one-third of Marin's population is expected to be age 60 or older.

2019 County of Marin Area Agency on Aging Older Adults Needs Assessment: Five of the most frequently indicated concerns by older adults in Marin were identified: 1) Climate change; 2) Disasters such as fire, flood or earthquake; 3) Affording healthcare; 4) Financial security; and 5) Losing memory/cognition. Among those 75 years or older, another major concern was crime, financial abuse and scams.

2020 Marin County Age Friendly Report: Feedback from more than 2,000 Marin County residents and community leaders has been incorporated into a new County of Marin action plan that puts forth a framework to make Marin more age-friendly. The County estimates that half of older adults need assistance at some point, resulting in a need for more services from government agencies, nonprofits, friends, and family. At the same time, Marin is ranked No. 1 on the list of California's healthiest counties, resulting in people living longer lives. About 28% of Marin residents are 60 years old or older, a figure 10% higher than the average California county, making Marin one of the oldest counties in the Bay Area. The share of older adults in our community is expected to increase and reach 35% by 2025 and grow to estimated 38% by 2030. Seventy-one Ross residents (10%) 60 years of age and older participated in this survey. Two of the needs identified by Ross residents are disaster preparedness and more local activities geared to older adults.

The following is demographic information for Marin County and the Town of Ross from the American Community Survey data (2013-2017).

The data will be updated once the 2020 Census is completed.

Town of Ross (2,311 total population)

- **60+ Population:** 768 (33% of the population)
- **Living Situation:** 96% own their own homes
- **Income:** Median household income is \$199,531; mean household income \$317,725; 2.9% live at or below the Federal poverty level
- **Race:** White 91.4%

Marin County (259,666 total population)

- **60+ Population:** 72,684 (28% of population/by 2030 38% of the population)
- **Living Situation:** 74% own home, 24% rent, 45% live alone
- **Income:** At or below Federal poverty level: 6%
- **Race:** Caucasian 90%, People of color 10%
- **Ethnicity:** Hispanic/Latino 5%

The Town of Ross received its Age-Friendly community designation in September 2019, joining 8 other Age-Friendly cities/towns in Marin. The next step is to develop an Age-Friendly plan specific to Ross. Five-Year CIP Projects Discussed

Town staff and Council discussed the various projects that are being proposed in the updated Draft Five-Year Capital Improvement Plan (CIP) for the Town. Capital improvement projects involve permanent structural improvement or the restoration of some aspect of the Town's property that will either enhance the property's overall value or increases its useful life. The CIP is intended to be dynamic in nature and will change from year to year as priorities, needs and funding change. The Five-Year CIP is a planning tool used by the Town to identify facilities and infrastructure improvements which will be considered for development over a five-year time frame.



Roadway projects selected for the Town's rehabilitation program are prioritized based on a condition-based assessment of the roadways, resulting in a Pavement Condition Index (PCI) for each street with the Town-maintained roadway system. The roadways included in the CIP for next fiscal year are the rehabilitation of Bolinas Avenue, which is a joint project with San Anselmo, and the rehabilitation of Thomas Court.

Woodhaven Road Recognized as Firewise Neighborhood



Congratulations to residents of Woodhaven Road for officially being recognized as a Firewise USA neighborhood - the first in Ross! Nine homes consisting of 18 residents, worked together on developing a risk assessment and action plan (which included vegetation management, evacuation routes, and educational outreach). They worked closely with the Fire Inspector and FireSafe Marin in this process. They are now a candidate to receive a Firewise grant in 2020 to be used towards making Woodhaven Road even safer during an emergency. This process allowed the residents to get to know each other as neighbors. Two fun block parties were held and residents that have lived there for 30+ years finally met one another. They are now connected to Ross Ready and plan to receive radio communication training. Well done!

The Firewise USA program encourages local solutions for safety by involving homeowners in taking individual responsibility for preparing their homes from the risk of wildfire. Using a six-step process, communities develop an action plan that guides their residential risk reduction activities, while engaging and encouraging their neighbors to become active participants in building a safer place to live. Winship Park is in the process of becoming a Firewise community and we strongly encourage other Ross neighborhoods to join together to become Firewise.

6 Redwood Project Completed

Work has been completed at the 6 Redwood site including the removal of the ivy and fencing adjacent to Ross Common. The result has opened up a dramatic view of the redwoods and palm tree on the site. Ross Common visitors now have a majestic view of the redwoods and additional plantings that were hidden behind the overgrown ivy and cyclone fence.

6 Redwood Drive is part of the Town-owned Ross Common which was purchased on July 1, 1911 from Annie S.E. Worn to be held, owned and used by the Town as and for a public park. The former residence that was on the 6 Redwood portion of the Ross Common was rendered uninhabitable as a result of a fire which occurred in February 2015. The Council voted to incorporate the space into the Ross Common park which would be consistent with the original purchase of the land.

The CIP includes a Laurel Grove Safe Routes to School project to be designed and constructed over the next two years that will provide a new pedestrian pathway on Laurel Grove from Sir Francis Drake to Canyon Way and will include some widening and reconfiguration of the roadway to accommodate a safe pedestrian route. The estimated project cost of \$700,000 will be partially funded by a \$400,000 Safe Pathways to School grant.



Bridge and drainage projects include the Winship Bridge replacement project, which is on track to be fully funded by the Highway Bridge Program (HBP) and some Marin County Flood Control Flood Zone 9 funding, is in the final stages of environmental analysis and construction is expected to occur in 2021/2022. In the next couple of years, the Town's drainage improvement projects will be smaller, localized replacement projects which are primarily identified in consideration of public safety and frequency of failure.

The public safety building and the Town Hall were originally constructed over 90 years ago and some of the buildings on the Town Civic Center site are physically and functionally obsolete and require significant dollars to rehabilitate or re-build new. In the next year, the Town will begin a Town Facility Master Plan for the Civic Center site which will provide the facilities goals and priorities, site analysis and program information, illustrative site plan (with multiple concepts reviewed in the process), phasing, and costs associated with the facility development. These processes will include significant community engagement and meetings to develop policies and facilities that best meet the needs for Ross.

In the past six months the Town completed two park projects in the rehabilitation of Natalie Coffin Greene Park and the landscape improvements to 6 Redwood connecting it to the rest of the Common. Next fiscal year, the Town will be conducting a landscape improvement plan for the Common with construction occurring within the next couple of years. ■


RECREATION NEWS
