Modernizing the Civic Center



Our Town's public safety building, which currently includes police, fire, and paramedics services, was originally constructed in 1927. It has served our community well over those 93 years, but now it is physically and functionally obsolete, with extensive structural deficiencies, and is not compliant with Essential Service Act (ESA) requirements for public safety buildings. A construction management company found it would be cost prohibitive to correct the numerous deficiencies and non-compliance issues.

In 2019 the Town and Fire Department hired a consultant, Citygate, to help us with fire protection planning. Citygate concluded that alternative approaches to fire protection in Ross are possible, based on the relatively low number of working fires over two-year period studied. In that same time period, the Ross station responded to 627 calls for service with 292 of the dispatches requiring lights and sirens. Of the 292 emergency calls, only 3 were for actual fires; 89% were for medical issues; and 10% were for other call types such as service calls and public assistance. Citygate also analyzed the impact on our current level of services if we received a response from a neighboring fire station, either San Anselmo (1.1 miles away) or Kentfield (0.65 miles away).

Relocating the fire station would increase response times for fires and non-medical calls for service by approximately 2 minutes. Maintaining an ambulance at the Ross Station would maintain the same response times for 85% of medical calls and would increase response times for the other 15% of calls by approximately 2 minutes when the ambulance is committed on other incidents. Average response times are currently 7:55 minutes. The increase to 9:55 would be similar to outer suburban averages. Currently, dispatch is already coordinated between San Anselmo,

retired from the RPOA Board. Collectively they served our Town for nearly half a century: Anne - 32 years; Iris - 12 years; John - 5 years. Each worked tirelessly, and we thank them.

Parents and the community are excited that children are finally able to return to Ross School, with distance learning outside. Soon students will also be back at Branson, which is similarly using outdoor areas as classrooms. Both schools have worked diligently for months to navigate a complex environment for safe reopenings.

Next weekend, on Friday, October 16 (4-9 pm) and Saturday, October 17 (10 am-8:30 pm), the Town will close Redwood Avenue (at the Common) and set up tables and chairs for outdoor dining. Thanks to our charming restaurants (**Crown & Crumpet; Marche aux Fleurs; Tony Tutto; Trattoria Fresco; Village Corner)**, we can enjoy a delicious meal outside with our neighbors.



Finally, thanks to **RossReady**, we have another opportunity to get better prepared for emergencies with another walkie talkie training on October II. While this will target our new Winship Park Fire-Wise Block Captains, all residents are welcome to join the Zoom call. If you'd like to join, email rossready94957@gmail.com. We thank **Gil Fleitas** and **Roger Dickerson** for spearheading these community-based volunteer programs.

We continue to hold all fire victims and fire fighters in our thoughts and prayers. Please stay safe! ■

November 3, 2020 Election

Vote by Mail

To prevent the spread of COVID-19 all active, registered voters will automatically receive a vote by mail ballot for the November 3, 2020 election. Ballots were mailed to voters starting October 5th. Ballots returned by mail must be postmarked on or before November 3rd, and received by the Elections Department by November 20th. Polling Place Change for Ross

Polling places in Marin County have been significantly reduced and consolidated with other nearby precincts due to COVID-19. There will **not** be a polling place this year in Ross. The County Elections Department has designated Ross voters to use the First Presbyterian Church in San Anselmo, located at 72 Kensington Road (near the Seminary). Polling places will open for 4 days starting October 31 through November 3. Ballots may be dropped off at a polling place or at any **Drop Box location**.

Ross and Kentfield. Assuming the community wants to keep paramedics, police and administrative facilities in Town, we have two options to address our fire services:

For about \$28.4 million, we can rebuild the fire station, along with police, paramedic quarters, and administrative space; or

For about \$14.6 million, we can relocate our fire staff to a neighboring station, and rebuild police, paramedic quarters, and administrative space.

Update on

Public Works Projects



The Bolinas Avenue pavement restoration project was completed last month. The project was constructed under a joint funding agreement with the Town of San Anselmo and features several traffic calming devices developed from discussions between the Ross and San Anselmo Town staff and the Bolinas Avenue Neighborhood Committee. The project retained the existing median islands and added new speed humps at locations between Richmond Road and Kensington Road.

Thomas Court also received a full-width asphalt grind and overlay restoration completing the Town's 2020 Pavement Restoration program.

The Allen Park Tennis **Court** restoration project is underway with a complete reconstruction of the court surfaces and the installation of some new netting and screening. The Courts are scheduled to be reopened by the end of October, weather permitting.

Downtown outdoor dining amenities project

The Town installed some outdoor dining amenities on Ross Common near Redwood Avenue. The new picnic tables represent an initial phase of various outdoor dining improvements planned for the downtown area. funded in part by a grant from the Transportation Authority of Marin (TAM).

With the increased use of the Ross Common for outdoor dining on the weekend comes a significant increase in trash, especially pizza boxes, on the Common. Town staff urges residents to properly dispose of pizza boxes and other compostable items in the green compost receptacles located nearby.



Halloween & COVID-19

COVID-19 has cast a pall over Halloween as the County Health Department released recommendations for this year's Halloween. Based on the recommendations, Shady Lane will not be closed this year to discourage people from congregating

on the street.



As the COVID-19 pandemic continues to cause illness, hospitalizations, and deaths in Marin County, the Marin County Department of Health and Human

Services (HHS) is offering families safe and responsible options for celebrating Halloween while preventing the disease's spread. HHS is urging residents to seek at-home and virtual festivities and strongly discouraging customary activities like door-to-door trickor-treating or large multi-household parties, which can be high risk for COVID-19 transmission.

Some safer alternatives for celebrating Halloween are:

- Online parties such as costume contests, pumpkin carvings or other virtual family celebrations.
- Car-based events (where individuals stay in their vehicles) such as: Drive-by events or contests where individuals dress up or decorate their vehicles; or
- Drive-in events where individuals can receive a treat bag (limited to commercially packaged nonperishable treats) or take away item(s) from an organizer while remaining in their vehicle.

Town LED Streetlight Program Brings Money Savings and Greenhouse Gas Reduction

In September 2018, the Town of Ross entered into an agreement with PG&E to have all of the Town's standard incandescent streetlights replaced with new, energy-saving LED fixtures. At no cost to the Town, over 200 street lights were converted and the project was completed in early 2019. Town staff recently compared actual electricity costs since 2018 for streetlights and found that approximately \$8,000 is saved annually, which equates to a reduction of almost 450 pounds of CO2 emissions every year.

RECREATION NEWS

Happy fall to everyone! We are entering our third session of Fall classes/programs and registration is currently OPEN with limited spaces. A note on the guidelines for registering for classes with schools re-opening; the CDC guidelines specify that children may participate in TWO

cohorts. This means that if your child is returning to in-person school, that is considered one cohort and they are able to sign up for one class outside of school. If you are NOT having your child return to in-person school, then they may sign up for two programs. Also, keep in
