This past year has been challenging on so many levels. I want to reflect on where we were when I began serving as Mayor a year ago: A few weeks into a novel shelter in place order, with no vac-

cine in sight; a couple months before the horrific George Floyd murder; and about half a year before record wildfires, smoke, heat and power outages. Each unprecedented.

<u>Pandemic</u>: We moved all meetings to Zoom and the Town Staff adjusted operating processes to deliver services following COVID-19 safety protocols. Amazingly, Town business continued uninterrupted, along with our Council meetings, with record resident attendance. We began to

Ross Welcomes New Police Chief



Town Manager Joe Chinn has named Raffaello "Ralph" Pata as the new Police Chief to lead the Ross Police Department effective March 30, 2021, replacing retiring Police Chief Erik Masterson.

Two panels comprised of Police Chiefs, Town management staff and a community member, interviewed a competitive field of candidates and provided feedback to the Town Manager who then held one-on-one interviews with the finalists. Pata stood out as a dedicated and enthusiastic law en-

forcement leader with 34 years of public safety experience in supervisory, management and leadership roles.

"We were extremely impressed with the expertise and credentials of the candidates we interviewed," Town Manager Joe Chinn said. "Through this highly competitive process, we gained consensus from the panels that Ralph Pata was the top candidate for the Police Chief position. Ralph has a deep commitment to serve and interact with the community and a proven track record as a leader and in collaborative and community policing. We are very excited to have him joining Ross."

A Marin County native, Pata was born and raised in San Rafael, and started his public service career as a San Rafael Fire Department Dispatcher at the age of 17. His law enforcement career began at the San Rafael Police Department in 1984 where he worked as a civilian employee until his promotion to officer at the age of 20 in 1985. Over his 34-year career, Pata served the San Rafael Police Department in virtually every capacity in progressively responsible roles, culminating in his promotion to Lieutenant. As Lieutenant, Pata created and managed the first San Rafael Homeless Outreach Team utilizing the first civilian mental health professional in Marin County assigned to a police department. His service working with advocates, the housed and unhoused community, as well as other departments at the City of San Rafael earned him employee of the year in 2013. He was responsible for co-teaching the Incident Management System to the Officers and leadership at San Rafael Police Department, served as commander of the crisis negotiation team, served as Lieutenant in charge of the Investigations Unit, and received three life saving awards. Since December 2018, Ralph has worked as a Marin

address other major issues, including our deteriorating Town facilities and the Corte Madera Creek flood risk reduction project. Many residents are now vaccinated.

<u>Social Justice</u>: In June we participated in the Black Lives Matter event on the Common, recommitting to equity. Councilmember Brekhus and I participated in county meetings about renaming Sir Francis Drake Boulevard, with Council voting in January against it (4-1), followed by most other affected jurisdictions.



<u>Wildfires and Climate Change</u>: Voters overwhelmingly approved the Marin Wildfire Prevention Authority (MWPA) and I joined its Board. During record-setting wildfires

and smoke, MWPA-funded inspectors showed residents how to harden their homes and create defensible space. Last summer, in the face of more power outages, Council adopted a Generator Policy. We reviewed the Town's Climate Action Plan, and added "Promote environmental stewardship" to our Town goals.

Today our lives are returning to a new normal. We are emerging stronger and more resilient for future challenges, with greater appreciation of things we once took for granted.

I am proud of how much we've overcome and accomplished. I thank my fellow Council members for their service to our Town and their support, especially Mayor Pro Tempore Robbins, and the Town Staff, especially Town Clerk Linda Lopez and Town Manager Joe Chinn. Finally, heartfelt thanks to Police Chief Masterson for his ten years of outstanding service, and a warm welcome to Chief Pata.

Temporary Prohibition of Public and Dogs on Ross Common

The Council revisited the discussion of the temporary ban of the public and dogs upon the Ross Common to facilitate in-person school and social distancing for Ross School students, faculty, and staff and for Ross Recreation programs under the Shelter in Place and Health Orders that have occurred with the COVID-19 pandemic. The ban has been in place since last summer when the Council adopted a Resolution which temporarily restricted public use of the Common at the request of the Ross School.

The temporary prohibition has allowed the School to utilize the Common for various activities throughout the school year. Since mid-March, the School has expanded its scheduling to include recess and electives with the grove area being utilized for recess and snacks five days a week. Starting on April 12, students will begin attending school all day and they plan to utilize the grove area of the Common five days a week. The School requested the grove area remain dog free for the remainder of the school year which ends June 10. Additionally, Ross Recreation has been able to utilize the grove area to facilitate social distancing for its afterschool programs. This summer, Ross Recreation will continue to keep their summer camps in socially distanced pods which will require using the grove area and field area of the Common.

The Council provided direction to continue to support the Ross School and Ross Recreation by keeping the current temporary prohibition in place.

Frederick Allen Park Community Workshop April 15



Town staff will host a virtual public workshop on Thursday, April 15, 2021 at 6PM to discuss the impacts to Frederick Allen Park from the Corte Madera Creek Flood Risk Manage-

ment Project being proposed by the Marin County Flood Control and Water Conservation District.

The goal of this public workshop is to provide background information to the public about the Corte Madera Creek Flood Risk Management Project and alternatives, answer the public's questions, and gather public input and sentiment about the available flood control options for Frederick Allen Park. After the workshop, a short questionnaire will be available until April 30th on the Town's website. The Town encourages everyone to participate in the questionnaire.

The results of this workshop and the questionnaire will provide important feedback to help inform the Town Council's discussion about the Town's preferred option for Frederick Allen Park.
