Here's a tidbit of Ross history: We all know that in 1982 an unrelenting rainstorm caused severe flooding and major damage in downtown Ross. But probably few remember the landslide the same storm triggered in a gully above Chestnut Avenue.

In our house at the corner of Bridge and Chestnut I heard the horn at the firehouse blow the code for a flood and hustled across the Lagunitas Road Bridge over the rising waters of Corte Madera Creek and on to San Francisco where I had a trial starting that morning.

By the afternoon, the Golden Gate Bridge and Highway 101 were closed and power and phones were out at our home

September is National Preparedness Month

With wildfire season upon us, it's important to be ready for an emergency. Here are preparedness tips to help you stay safe.

TIP: Alerts

- Sign up for [AlertMarin](#) to receive critical information during an emergency/disaster with action required — **This is your baseline for preparedness.**
- Sign up for [Nixle](#) to receive general public safety information alerts via text based on your zip code
- Stay informed with [PGE PSPS Address Alerts](#)

TIP: Taking Action

- [Make A Plan](#) to ensure you have a meet-up location for those close to you, contact information, and out-of-area contact
- [Gather Emergency Supplies](#) in case you Stay (shelter in place) or Go (evacuate) and organize them into a Stay Box and a Go Bag
- [Last Minute List](#) contains those things you want to take with you if you have time

although friends reported that my family was safe. I stayed in a hotel near my office and bought a new shirt, underwear and socks each day after court. By the fourth day, phone service was restored, but not power, and I drove home via the East Bay. Entering a darkened Ross I encountered a military guard at Lagunitas Road and Willow Avenue. After proving my identity, I was allowed to continue to my home.



At daylight I saw and learned that on the day of the flood a torrent of mud had come from above Chestnut Street, through our backyard and onto Bridge Road and the property next door. It had torn a corner off our neighbors' home, pushed the paved surface of Bridge Road out of the street, knocked a brick wall across the street down and pushed a car from the street into a swimming pool on the property across the street. The mud continued onto an adjacent property on Brookwood Avenue and pushed the occupants out of the front of their house. They arrived at their neighbors' house covered in mud from head to toe.

We had the fences around our back yard knocked down and we were left with a layer of about six inches of mud and debris over our backyard but somehow our house suffered no damage.

I'm afraid there's no deep philosophical lesson embedded in what I've related other than perhaps "You never know." ■

Electric Vehicle Station Parking Ordinance Adopted



Town Council adopted a new Electric Vehicle (EV) Station Parking Ordinance which restricts parking in all public EV charging station stalls in Ross to actively charging EV's only. The Town currently has two EV charging stations in the Post Office parking lot. The Ordinance provides for the issuance of parking fines if non-EV vehicles occupy these spaces

or if any vehicle blocks access to these spaces.

The fines for illegally parking in the EV stalls are set by the Marin County Superior Court and are subject to change annually. The Ordinance goes into effect on September 30, 2022.

Fernhill Paving Begins August 17

Town Council awarded the Fernhill paving project to Maggiora and Ghilotti, the lowest responsive bidder out of 4 bids received by the Town. Residents on Fernhill Avenue, Shanley Lane, Park Drive (Branson), and Circle Drive will experience traffic restrictions beginning Wednesday, August 17th. The most restrictive day will be Friday, August 18th when asphalt paving operations will close off the roadway beginning in the morning at Glenwood and proceeding downhill toward Shady throughout the entire day. Depending on the weather, segments of the roadway will reopen approximately 4 hours after paving. Town staff will continue to coordinate with local residents and Branson School staff to provide accurate schedules early next week before construction starts. Branson classes begin on August 23rd after most of the project work should be completed. Pedestrian traffic on Fernhill should be unrestricted throughout construction but please stay alert and safe whenever construction equipment is operating.

Local Hazard Mitigation Plan Annual Report

Town staff presented the 2022 annual evaluation report on progress towards implementation of the adopted 2018 Marin County Multi-Jurisdictional Local Hazard Mitigation Plan (MCM LHMP). The Annual Report lists the progress on the implementation of the 2018 MCM LHMP local and regional goals. The MCM LHMP was adopted by the Town on January 10, 2019 and evaluates hazard risk mitigation for five primary risk categories: earthquake, flooding, wildfire, landslide, and Phoenix Lake Dam inundation.

Housing Element Update



Work on the Housing Element Update continues apace, with a public review draft scheduled for release in late September. An online survey went live on July 12, following the first community workshop to provide additional opportunities for Ross residents to have their say. The survey is intended to gauge interest in ADUs in the community and responses will help make the case that ADUs are an important part of the housing element puzzle in Ross. To date, 104 residents have responded but our goal is to hear from 200 residents so the survey deadline will be extended to August 18. At the Council's meeting in September, the Council will review a draft of the core components of the Housing Element Update developed with community input: the sites map, inventory of projected capacity of the sites, and the program of actions, which represent the commitments the Town will make to meet State requirements for promoting housing at all levels of affordability over the next 8 years. Following that meeting, additional outreach activities are planned, including a second community workshop, a presentation at the Age-Friendly brunch event September 20, and pop-up events around Town. Council Adopts Adding Juneteenth Holiday



The Council adopted a Resolution declaring June 19th (Juneteenth) a holiday every year in the Town. On June 17, 2021, President Biden signed a bill creating Juneteenth Independence Day commemorating the end of slavery and recognizing June 19th as a federal holiday. The majority of cities in Marin County have already declared Juneteenth as a holiday and the remaining cities are planning to consider the action in the coming months.
