As we reach the end of 2022, I'd like to highlight some of the achievements made by the Town Council and Town staff over the past year. It's important to note that most of staff's time is devoted to providing

day to day services to the Ross community throughout the year. Public safety calls for service are responded to. Streets, storm drains, parks and facilities are maintained. Land-use issues are addressed and customers are served. Elections and public meetings are conducted properly, quality recreation programs are offered, and other important services provided.

Housing Element Update - Next Steps

After 8 months of community outreach and discussion, last night the Town Council directed staff to send the Draft 2023-31 Housing Ele-

ment to Sacramento for review. Under State law, the California Department of Housing and Community Development (HCD) is required to review the Draft Element as part of the update process. HCD has 90 days to complete its review and return comments to the Town.



Like other communities in the Bay Area, Ross is required to update the Housing Element of our General Plan to address local housing needs and new State laws. Amid the ongoing housing shortage in California, Ross is required by law to plan for at least III new housing units over the next 8 years. The Draft Housing Element incorporates strategies to help the Town meet its legal requirements while preserving the unique and historic sense of place so important to our community. These strategies include providing workforce housing for police officers, fire fighters and others who work in Ross on the Civic Center site and working with the Branson School to facilitate the construction of housing for teachers on its campus. With few vacant lots readily available for housing development, a critical part of the housing plan involves promoting and incentivizing the creation of accessory dwelling units (ADUs) on existing singlefamily properties throughout Ross. Given their smaller size and lower costs, ADUs can provide a valuable source of housing for seniors, nannies, au pairs, and in-home caregivers as well as for students at the nearby College of Marin, teachers at Ross Elementary and the Branson School, public servants, and others who work in the area.

functions is management of the Town's finances. During this past year, we obtained approval of the annual audit; regularly paid bills; complied with grant and State Controller reporting requirements; and balanced the books every month. With input from the community, we approved a balanced Fiscal Year 2022-23 budget that maintains service levels, reduces the Town's pension liability and adds to the Facilities & Equipment Fund which serves as the Town's savings account for future improvements for Town facilities.

I would also like to highlight three planning related projects that were initiated or completed in 2022: completed the process to amend Branson School's Conditional Use Permit allowing the school to increase enrollment; made significant progress on the Housing Element Update process; and moved the Town's civic center project forward by initiating a Master Facilities Planning process.

Pickleball Anyone?



The popularity of pickleball has increased dramatically across the country and is a very social game. In response to the high demand for



pickleball courts, the Council requested that Town staff explore the costs and logistics of adding pickleball courts to the Ross Town Tennis/Platform Court Facility. Town staff sent out surveys to the resi-

dents and had 165 completed surveys. The results showed an overwhelming response (71%) that there is a desire to have pickleball courts added to one tennis court to make it a multiuse resource for the community.

The survey results were brought to the December 8, 2022 Council meeting with the recommendation from Town staff to have Town Council implement a trial pickleball program by adding four pickleball court lines to one tennis court. The Town Council approved this recommendation and Town staff will now move forward with the project.

Marin Sanitary 2023

The Council approved the Marin Sanitary Service (MSS) rate increase of 6.28%



for 2023. The Town of Ross participates in a Franchisor's Group comprised of San Rafael, Fairfax,

Larkspur, San Anselmo, Las Gallinas Valley Sanitary District, and a portion of Marin County. This year, R3 Consulting Group, Inc., has determined a 6.28% rate increase is appropriate for ratepayers in Ross which include residential homeowners, apartment owners, commercial property owners, and other businesses and tenants. The MSS solid waste service collection, processing, disposal, and recycling service cost in Ross increases from \$43.43 per month in 2022 to \$46.16 per month in 2023, for the 32-gallon cart service. The proposed rate of \$46.16 is lower than the Marin County average for non-MSS service agencies of \$52.86. Of the MSS service agencies in Marin County, Ross has the second lowest rate.
