## Mayor's Corner

Summer is over and Ross school is back in session. Welcome to the new Superintendent, Dr. Michael McDowell, as well as the new teachers, and new students and kindergard-

ners. Please be mindful of school traffic in the morning and afternoons.

One of the key projects the Town has identified for this fiscal year is a comprehensive Building and Planning Fee Study. The project was approved last March at the council meeting, but not begun because we had an interim Town Manager. We launched the study in early August, and it is expected to be completed before the end of the calendar year. Up until three years ago, Building and Planning fees were substantially subsidized by property taxes. Not only

## **Flood and Winter Preparedness**





The Town of Ross is preparing for the anticipated "El Nino" weather pattern during the upcoming rainy season. The Town, the residents, property owners, and the Marin County Flood Control all play an important role in preparing for the upcoming rainy season.

Drainage infrastructure maintenance is routinely scheduled by the Town for the fall of each year, and there are Capital Improvement Projects for drainage repairs that will be occurring in the next few months for culverts on Fernhill Avenue, Brookwood Lane, Allen Avenue, and Madrona Avenue.

Property owners are responsible for the maintenance of all watercourses that pass over, under, and in many cases around their property. Whether it is an open ditch or a culvert on or adjacent to your property, they are to be kept clean and free of debris that can obstruct the natural flow of water.

The Public Works Department will be sending out notifications to property owners for general and specific drainage/creek maintenance actions, including vegetation and debris removal as appropriate. Now is the time to go out and check your property for possible tree hazards. If you have dead or dying trees, please come to Town Hall and get a tree removal permit as soon as possible.

Sand bags and sand for residents will be available at Natalie Coffin Greene Park and possibly another designated location in the Town of Ross. Flood gates in the commercial area on Ross Common should be checked now by the owners and/or occupants for maintenance and proper operating procedures. The Town of Ross is preparing an action plan for employees that will include additional public notifications and coordination. Information will be distributed to residents via letters, email, and postings around town, so stay tuned.

did building project fees not cover the actual costs, it meant that the Town was pulling from reserves to balance the budget, while also cutting services. The fees were increased several years ago to reduce the subsidy. The detailed fee study of all the Town's fees is very important because it will indicate which fees might need to be adjusted – both lower and higher – based on the current cost of service provision. We will keep you updated as this project progresses.

Some important Town dates to note, consider, and hopefully attend:

- Saturday, Sept. 12 from 9 AM to 1 PM at Ross School gym, there will be a First Aid for Disaster Response class sponsored by the Disaster Preparedness Committee and RPOA. Parents whose kids ride bikes or skate boards, sports coaches, babysitters, teachers and anyone concerned with safety should attend. To sign up, email Patti Shimek at p.shimek@comcast.net. There is no charge to attend (it's FREE!) and space is still available.
- The annual meeting and luncheon for the Moya Library & Ross Historical Society will be Friday, September 18th, 11:00 AM, at the Marin Art and Garden Center, commemorating the 70th anniversary of the Marin Art & Garden Center. Tickets for the luncheon are \$45 and for the presentation only, \$10.
- The Town Dinner is Friday, September 25th, also at MAGC. Please RSVP if you have not done so (see details of event on page 4). At the upcoming Town Dinner, Ross School will be collecting gently used books which will be donated to underprivileged communities. There will be receptacles near the entrance. Please consider donating your books to this good cause. Enjoy the dinner with your fellow Ross residents!

# Streamlined Process for Residential Rooftop Solar System Permits



Assembly Bill 2188 (AB2188) amended the California Solar Rights Act to encourage deployment of solar en-

ergy systems by reducing the costs and delays associated with local permitting processes. Every city and county must adopt an ordinance that creates an expedited, streamlined permitting process for small residential rooftop solar energy systems, on or before September 30, 2015. Cities and counties are also required to adopt a checklist of all requirements than an applicant must comply with for a small residential rooftop solar energy system to be eligible for expedited review. The streamlined permitting process and checklists must substantially conform to the most current version of the California Solar Permitting Guidebook. The ordinance introduced at the September Council meeting adopts by reference, the California Solar Permitting Guidebook, with no changes at this time, but the ordinance allows the Building Official to update the checklists over time as needed. ## **Older Adults Needs Assessment Survey**

The Marin County Area Agency on Aging (AAA) is currently conducting a needs assessment of older adults to guide the County in determining the funding



priorities for the next four years. This assessment asks older adults about their needs, concerns and priorities. The Plan determines the goals and direction of the AAA for the next four years. The results of the survey will help define funding allocations for critical services such as, but not limited to, case management, senior center activities and nutrition programs such as congregate meals and home delivered meals. If you are over 60 please consider taking this assessment. If you know of someone who is 60 and older and living in the county, please pass this information on to them so their voice can be heard. # PUBLIC SAFETY

#### **Back to School Safety**

Now that school is back in session, it is a good time to remind parents and children of the following.

#### If kids are walking:

- Map out a safe route to school and walk it with your child for a few days so they become familiar with the way.
- Make sure your child crosses at intersections where there is a crossing guard.
- Have children wear bright clothing that can be seen by drivers.

#### Riding or driving in the car:


- All children should wear a seat belt or use an ageappropriate car seat or booster seat.
- If you have a teen driving to school, make sure they drive safely by using a seat belt at all times, limit the number of passengers, and remind them about use of cell phones while driving.

#### On a bicycle:

- Make sure your child always wears a helmet.
- Teach them to ride in the same direction as traffic, on the right side of the road.
- Show your child the appropriate hand signals for turning.
- Explain the "rules of the road" obey stop signs and traffic lights.

## Tips for driving in a school zone (especially during drop-off and dismissal times)

- Slow down. The simplest thing any driver can do when there are new driving hazards is slow down.
- Allow More Time. As a new school year begins allow yourself more time to get where you are going until you can figure out the effects of increased traffic. Stay Alert! Make a mental note of any new bus stops or students walking to and from school. This way you won't be surprised and will be prepared if you need to stop.
- Learn the Rules. Schools usually have places for parents to drop off and pick up children. If you are driving your child to school learn where these areas are and follow the procedures. If you need to go into the school ask where you can park your vehicle so traffic can continue to move smoothly. Never block pick and drop off areas.
- Carpool. If at all possible carpool with other parents to pick up and drop off children. This reduces congestion and can even save you money. ■
